<p><b>MUST PROVIDE IRS PROOF OF NON-PROFIT STATUS.</b></p> <p><b>Definition of a Non-Profit:</b> A corporation incorporated pursuant to the Nonprofit Corporation Law that is exempt from taxation and can show proof with a 501(c) form from the Internal Revenue Service. An organization that was organized for and is in operation for charitable purposes and meets the requirements of Section 214 of the Revenue and Taxation Code.</p> <p><b>Non-Profit Information Booth:</b> Booth space is limited to non-profit organizations for the express purpose of distributing and disseminating information and educational material. Onsite sales and raffles are not permitted. • Distribution of food or water is not permitted.</p> <p>• Vendors are restricted from giving away products or services that the EGSP contracts with others for. *Informational handouts must be larger than 3x5 card.</p> <p><b>Non-Profit Fundraising Booth</b> • Booth space is limited to non-profit organizations for the express purpose of distributing and disseminating information and educational material and that wish to sell merchandise or conduct any type of fundraising.
